APPENDIX A

a) Age UK

Thank you for your email requesting information regarding the work we do in Haydon Bridge, and thank you once again for the donations we have received.

2020 has been an unprecedented year for everyone. Our Information & Advice, Advocacy, Befriending and Health and Wellbeing teams have remained on hand to provide support to new and existing clients, all via the telephone. All of our activities, exercise classes and social groups have been postponed until further notice.

This year we have supported Haydon Bridge as follows:

- There have been calls to Age UK Northumberland requesting help and advice from our Information & Advice and Advocacy teams on a number of topics including welfare benefits
- We have provided 120 isolation packs, distributed by the Haydon Bridge Care Group, during April and May (25 in April and 2 separate deliveries in May totalling 95 packs)
- We have provided 170 activity packs again distributed by the above group. 70 were distributed in August (Edition 1) and 100 in December (Edition 2). We were able to supply 60 boxes of biscuits to be handed out in December too
- Each of the activity packs contained a leaflet explaining our services and encouraging people to contact us if they needed any information and advice.
- In February 2021 we will be producing Edition 3 of our activity pack and we will be supplying at least 100 copies to the Care Group for distribution.

b) MENCAP

Here's a bit more on the impact of the coronavirus on Mencap in the local area, how we have responded and how we have supported people in the local area during this time.

Many of our services in the local and surrounding area have been forced to move online, but have continued virtually. This includes our befriending schemes and our gardening clubs. Our support workers have still been active in the local community, aiding people in the area with a learning disability who require their support.

Nationally, we have provided accessible advice for people with a learning disability, helping break down the ever changing guidance which is often very unclear. We have also continuously lobbied government for more support and protection for people with a learning disability.
